


This chart shows the total general purpose revenue Heritage Peak Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Heritage Peak Charter School is \$13,640,542, of which \$11,640,114 is Local Control Funding Formula (LCFF), \$246,010 is other state funds, \$540,532 is local funds, and \$1,213,886 is federal funds. LCFF Funds, \$1,129,854 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


